To whom it may concern,

Richardson Inspection Services has inspected the above-mentioned property on two (?) separate occasions, resulting in action being taken in accordance with the provisions of the International Property Maintenance Code. On May 2, 2023 a Notice of Violation was issued for the property and the owner was given thirty days to abate the violations. A follow-up inspection was conducted on June 5, 2023 which resulted in an Order to Show Cause being issued when the violations were noted to still be present. At that time a Demolition Order was also issued against the property.

Since then, it has been brought to our attention that the facade - which was mentioned as an issue in the Notice of Violation - did collapse. This brings into play Section 109 of the Ordinance which deals with Emergency Measures. It is our belief that the remainder of the facade is in imminent danger of collapse and endangers the safety of those in the vicinity. Section 109.2 of the IPMC states that: Notwithstanding other provisions of this code, whenever, in the opinion of the code official, there is imminent danger due to an unsafe condition, the code official shall order the necessary work to be done, including the boarding up of openings, to render such structure temporarily safe whether or not the legal procedure herein described has been instituted; and shall cause such other action to be taken as the code official deems necessary to meet such emergency. In order to safeguard the structure, we recommend that the entire facade be removed. Pursuant to the code, the borough has the right to do so, and can exercise that right without regard to due process when conditions warrant it, as is the case here.

In conclusion, we feel it would be prudent for the borough to remove the facade completely and pursue steps to demolish the building and pursue reimbursements through liens. RIS will continue to pursue court hearings for restitution.

#### CONDITIONS, CHARACTERISTIC, AND LIMITATIONS OF HOT MIX ASPHALT

- The warranty period for all asphalt work shall be one (1) year on materials and workmanship, from the date of completion. The warranty covers failure to the asphalt surface which could occur due to a faulty mix or failure of the base. This includes premature excessive cracking and crumbling and excessively deep water puddles. The warranty excludes any puddles on surface with less than 1.5 percent grade and normal wear and tear.
- Most cracks occur during the natural aging process, which consists of the hardening and shrinking of asphalt, along with the freeze and thaw cycle of the seasons. The most common type of crack is a hairline crack. If you have a hairline crack in the surface, it does not require any corrective action. If the hairline crack expands to 1/4" wide by 1/4" deep within the first year, we will fill it with a liquid crack filler at no charge.
- The base is the most important part of asphalt paving. Warranty work would not be covered if the base work was performed by another company. When paving over concrete, brick or an existing asphalt surface, we are not responsible for the reproduction of cracks or expansion joints which may occur.
- When adding additions or extensions to existing asphalt, there will be a difference in the base, which may cause unequal
  movement over time. We are not responsible for the production of seams which may occur.
- The warranty excludes any cracking or settling of pavement caused by sub-surface ground conditions or cracks developing from tree roots, which can not be avoided. As trees grow, so do the root systems.
- The edge of an asphalt surface is its weakest point. It is highly recommended that the customer shore up the edges with rock or topsoil and grass seed, to help prevent breakage. Driving automobiles close to or over the edges of new asphalt will cause breakage. This type of damage is not covered under our warranty, so it is up to the owner to carry out
- Asphalt, when hot, will get soft. This is not a sign of bad material or lack of rolling but a natural characteristic.
- Spinning tires or turning the steering wheel of a stationary vehicle on new asphalt on a very hot day may cause raveling, blemishes or tire marks. Tire marks may also happen where the turning radius is short. This type of damage is not covered under our warranty, so it is up to the owner to carry out precautions.
- High heel shoes, ladders, bike stands, chairs, tables, and other weighted and pointed objects will make holes in asphalt.
   This type of damage is not covered under our warranty, so it is up to the owner to carry out precautions.
- Gasoline and oil will erode asphalt; salt will not. Clean up gas and oil spills as soon as possible by diluting with soap and water.
- Newly paved surfaces will not be smooth until several seal coats. Sealing two consecutive years then every other year is
  recommended and is customer's responsibility.
