- Resubmission of signage proposal from The Brown Dog Sign Company.

- The Mission Co to coopt a Koppel Fall Community Day on October 26th. Dinner will be provided along with food distribution. Koppel Park ribbon cutting ceremony to follow. Refreshments and a game of "Catch the Cops" for local children will follow.
- Trick or Treat tentatively scheduled for Thursday, October 31st. Discussion to add optional parade beforehand with a slight shift in the normal hours. Discussion to allow horses to parade during the event.

NEW BUSINESS

- Recap of Connect Beaver County Broadband Program meeting announcement.
- Permitting is required for Koppel Park Swing sets and pavilion. Permits can be obtained through Richardson Inspection, but an architectural drawing is required for the pavilion. Motion to contract Franus Architectural Associates to complete the draft for \$1,600. With required amendments to the original design plan, contractor Daniel Byler will increase project total to \$16,600. Motion to increase project cost for a total cost of \$18,200. Byler stated the pavilion installation will begin the first week of October.
- Councilman Serge suggests scrapping/selling materials from the church building to help pay for Koppel Park.
- Removal and scrapping of Koppel Park bleachers for safety.
- Home Depot has generously donated two park bench kits. Thank you, Home Depot Chippewa!
