# Tracy Frampton, EADS <u>ARPA Grant</u>

Application for the American Rescue Plan Funding and in addition to the allotment received by the Borough, Beaver County received a grant as well and they will commit to give funding for infrastructure. Primary uses of the grant are for sewers, storm sewer and broad band. Since storm sewers are an issue in Koppel it is an excellent opportunity for apply. Last year, Koppel received a \$90,000 grant from CDBG and was referred to as Phase 1 Storm Sewer Project. An application was applied and not awarded for Phase 2. This new application, ARPA Grant is an 80/20 grant and the engineering cost are included. If awarded, will help to complete the storm sewer on Arthur Street and the total cost of the project is \$528,000. There is no cost to the Borough for the application of the grant to be completed by EADS.
