REPORTS

Zoning Officer Report

Owen Pella provided a zoning report for April 2022. The zoning report in its entirety is available for view at the Koppel Borough Municipal office.

Further questions were asked by Council about the procedures for the condemnation of 3302 3rd Avenue. The Borough Council decided not to secure the structure following condemnation as advised by the Borough Solicitor. Approval for cutting bushes at the property in the right-of-way was requested and approved.

Police Department Report

Richard Conti, Jr. has applied for employment as a part-time officer with Koppel Borough and Chief Justin Warren made a request to hire him.

Fire Department Report

Koppel Borough engine was repaired and paid for by the Koppel Fire Department. Devon Price attended classes for certification training. Tim Brewer reported that the Koppel Borough Fire Department will be having a fundraiser luncheon dinner on June 25th and will serve pulled pork, baked beans and coleslaw for \$8 on a first come first serve basis.

Maintenance Report

Mike Stabryla, Maintenance, reported that animal feces on 4th Avenue has been a problem. Council advised Mike to notify the police when he encounters people not using bags to pick up their dog's feces. Repairs to both police vehicles need to be done and a request to purchase acetylene tanks was made. Council needs a cost estimate to purchase before approval. A fence made of pipe is needed at the end of Richard Street near the railroad tracks and a request for approval to put one in was made and Council approved its installation. The bushes in the right-of-way will be cut at 3302 3rd Avenue when there is time.

The need to repair the railroad crossings were brought to the attention of council. The ties have rotted and bolts are protruding. Past requests have been made with no result. Contact information was given to Chuck Bevington to contact the railroad.

Resolve: Councilman Bevington phoned the railroad requesting that the repairs be made and asked that they also spray the weeds along the tracks. The railroad responded that they will look into the request.

Engineer's Report

Brandon Fombelle, Engineer, reported that he is tracking the icing issue on SR 351 near the bridge. The property owner is working with PennDOT to determine the source of the water running on the road near the bridge. PennDOT has made repeated visits at the traffic signal and adjustments were made, but replacement is needed, and not much can be done until that is accomplished. Brake retarder signs need to be installed and the directions for placement were sent to Council by Brandon. Those directions are to be emailed to Jeff Dengler who will help with installation.

Solicitor's Report

Joe Budicak, Solicitor reviewed the weight limit ordinance and told council he will advertise. He will follow through with 3302 3rd Avenue.

Mayor's Report

GOOFY GOLF

Jeff Potter will be in Koppel for Goofy Golf on July 14th. Club Hope will join in and co-host the event. The concession stand will be open for this event.

FISHER'S OF MEN
