

ORDINANCE NO. 205

AN ORDINANCE PRESCRIBING TRAFFIC AND PARKING REGULATIONS IN THE BOROUGH OF KOPPEL, BEAVER COUNTY, PENNSYLVANIA, AND PROVIDING PENALTIES FOR THEIR VIOLATION.

THE BOROUGH OF KOPPEL HEREBY ORDAINS AS FOLLOWS:

SECTION 1. DEFINITIONS AND INTERPRETATION. WORDS AND PHRASES, WHEN USED IN THIS ORDINANCE, SHALL HAVE THE MEANINGS ASCRIBED TO THEM IN THE VEHICLE CODE OF PENNSYLVANIA, AS NOW IN FORCE, OR AS HEREAFTER AMENDED, ENACTED OR REENACTED, EXCEPT IN THOSE INSTANCES WHERE THE CONTEXT CLEARLY INDICATES A DIFFERENT MEANING.

SECTION 2. MANNER OF ADOPTING PERMANENT TRAFFIC AND PARKING REGULATIONS. ALL TRAFFIC AND PARKING REGULATIONS OF A PERMANENT NATURE SHALL BE ENACTED AS ORDINANCES OR AS PARTS OF ORDINANCES OR AS AMENDMENTS TO ORDINANCES OF THE BOROUGH OF KOPPEL.

SECTION 3. U TURNS PROHIBITED ON CERTAIN STREETS. NO OPERATOR OF ANY VEHICLE SHALL MAKE A U-TURN AT THE INTERSECTION OF FIFTH AVENUE AND ARTHUR STREET. ANY PERSON WHO SHALL VIOLATE ANY OF THE PROVISIONS OF THIS SECTION SHALL, UPON CONVICTION THEREOF, BE SENTENCED TO PAY A FINE OF TEN (\$10.00) DOLLARS AND COSTS OF PROSECUTION, AND, IN DEFAULT OF PAYMENT OF SUCH FINE AND COSTS, TO IMPRISONMENT IN THE COUNTY JAIL FOR NOT MORE THAN FIVE DAYS.

SECTION 4. PARKING. (A) PARKING SHALL BE PROHIBITED AT ALL TIMES ON ALL ALLEYS IN THE BOROUGH. (B) DOUBLE PARKING SHALL BE PROHIBITED AT ALL TIMES ON ALL STREETS IN THE BOROUGH. ANY PERSON WHO SHALL VIOLATE ANY OF THE PROVISIONS OF THIS SECTION SHALL, UPON CONVICTION THEREOF, BE SENTENCED TO PAY A FINE OF NOT LESS THAN TWO (\$2.00) DOLLARS NOR MORE THAN TEN (\$10.00) DOLLARS AND COSTS OF PROSECUTION, AND, IN DEFAULT OF PAYMENT OF SUCH FINES AND COSTS, TO IMPRISONMENT IN THE COUNTY JAIL FOR NOT MORE THAN FIVE DAYS.

SECTION 5. STOP INTERSECTIONS ESTABLISHED. THE FOLLOWING INTERSECTIONS LOCATED IN THE BOROUGH ARE HEREBY DECLARED TO BE STOP INTERSECTIONS, AND OFFICIAL STOP SIGNS SHALL BE ERECTED IN SUCH A POSITION AS TO FACE TRAFFIC APPROACHING THE SECOND-NAMED STREET IN THE DIRECTION OR DIRECTIONS HEREBY INDICATED. ALL VEHICLES APPROACHING THE INTERSECTION UPON THE FIRST-NAMED STREET IN THE DIRECTION OR DIRECTIONS HEREBY INDICATED IN EACH CASE SHALL COME TO A FULL STOP, WITHIN A REASONABLE DISTANCE, BEFORE ENTERING SAID INTERSECTION:

(1) ARTHUR STREET AND SIXTH AVENUE, FACING EAST BOUND AND WEST BOUND TRAFFIC.

(2) RICHARD STREET AND SECOND AVENUE, FACING WEST BOUND TRAFFIC.

(3) RICHARD STREET AND FIFTH AVENUE, FACING EAST BOUND AND WEST BOUND TRAFFIC.

- (14) MARY STREET AND THIRD AVENUE, FACING EAST  
BOUND AND WEST BOUND TRAFFIC.
- (15) MARY STREET AND SECOND AVENUE, FACING WEST  
BOUND TRAFFIC.

ANY PERSON WHO SHALL VIOLATE ANY OF THE PROVISIONS OF THIS SECTION SHALL, UPON CONVICTION THEREOF, BE SENTENCED TO PAY A FINE OF TEN (\$10.00) DOLLARS AND COSTS OF PROSECUTION, AND, IN DEFAULT OF PAYMENT OF SUCH FINE AND COSTS, TO IMPRISONMENT IN THE COUNTY JAIL FOR NOT MORE THAN FIVE DAYS.

SECTION 6. ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT WITH THE PROVISIONS OF THIS ORDINANCE BE AND THE SAME ARE HEREBY REPEALED.
