ORDINANCE NO. 233

AN ORDINANCE PRESCRIBING THE CLASSES OF VEHICLES ON CERTAIN STREETS IN THE BOROUGH OF KOPPEL AND PROVIDING PENALTIES FOR THEIR VIOLATION

BE IT ORDAINED AND ENACTED by the Town Council of the Borough of Koppel and it is hereby ordained and enacted by authority of the same:

SECTION I - DEFINITIONS AND INTERPRETATIONS

Words and phrases when used in this Ordinance shall have the meanings ascribed to them in the Motor Vehicle Code of the Commonwealth of Pennsylvania, as now in force or as hereafter amended, except in those specific instances where the context of the Ordinance clearly indicates a different meaning. The singular shall include the plural and the masculine shall include the feminine.

SECTION II - CERTAIN CLASSES OF VEHICLES ONLY PERMITTED ON CERTAIN STREETS IN THE BOROUGH OF KOPPEL

The following streets are hereby set aside for the use of passenger motor vehicles and trucks making local deliveries to the residents of Koppel only, and no person shall operate any commercial vehicle, truck, bus, or any truck or passenger vehicle drawing any trailer or towing any other vehicle upon such streets at any time in the Borough of Koppel:

- (a) Frank Street
- (b) Mary Street
- (c) Ida Street
- (d) Mount Street from Second Avenue to Fifth Avenue
- (e) Richard Street

- (f) First Avenue
- (g) Second Avenue
- (h) Third Avenue
- (i) Fourth Avenue
- (j) Sixth Avenue

Provided, however, that any resident property owner of the Borough of Koppel who is engaged in a trucking operation and uses his real estate to park his vehicle, shall be able to traverse the streets of Koppel to his home as long as the commercial vehicle, or truck or commercial vehicle or truck that is hauling or towing a trailer is not loaded and has a weight of less than 22,000 pounds.

SECTION III - SEVERABILITY

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not effect or impair any of the remaining clauses, provisions, sentences, sections or parts of this Ordinance. It is hereby declared by the intent of the Council that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

SECTION IV

Any Ordinance or part of any Ordinance conflicting with this Ordinance, be, and the same is hereby repealed insofar as the same effects this Ordinance.

SECTION V - ENFORCEMENT

Any Person who shall violate any of the provisions of this Ordinance shall, upon conviction before a magistrate or justice of the peace of the Borough of Koppel, Commonwealth of Pennsylvania, be

Any Person who shall violate any of the provisions of this Ordinance shall, upon conviction before a magistrate or justice of the peace of the Borough of Koppel, Commonwealth of Pennsylvania, be sentenced to pay a fine of TWENTY-FIVE (\$25.00) DOLLARS and in de-

fault of such fine and costs of the prosecution, to imprisonment in the County Jail for not more than ten (10) days.
